1. Event Details

Event: Asian Para Games
2026 Venue: Aichi-Nagoya,
Japan Dates: 18 to 24
October 2026

2. Selection Criteria

The selection of players will be carried out in accordance with the guidelines and eligibility criteria issued by the Asian Paralympic Committee (APC) and the Boccia International Sports Federation (BISFed) for Para Boccia.

BSFI will strictly adhere to:

- Qualification standards set by Asian Paralympic Committee APC
- Regulations and eligibility criteria prescribed by BISFed
- Final slot allocation and confirmation by the organizing authorities. & BISFed.

3. Eligibility

- Players must meet the classification requirements as per BISFed regulations.
- Players must be in good standing with BSFI and comply with all national and international participation norms.
- Players must fulfill all entry and documentation requirements within the stipulated timelines.

4. Selection Process

- Selection will be based on:
- BISFed/Asian Boccia rankings
- Recent international and national performances
- Availability of quota slots allocated to India
- Final selection will be subject to base on trials will be conducted by BSFI and approval by the Selection Committee of BSFI.

ALLOCATION OF QUALIFICATION SLOTS

- A Pairs qualification slot is allocated to the country not to an individual athlete. An Individual qualification slot is allocated to the individual athlete not to the Country.

- Be internationally classified in an eligible Sport Class with a Sport Class status of (i) 'Confirmed', or 'Review' with a Fixed Review Date after 24 October 2026

- Must be listed in the BISFed Para Boccia World Ranking list published on 14 July 2026.
- Be classifiable in accordance with the World Boccia International Classification System.
- Be 15-years-old before January 1st 2026
- Have an Active License
- Have a valid WADA International Level Athletes Education-Program Certificate
- An athlete should be in good standing with the Boccia Sports Federation of India (BSFI).
- **Individuals**
 - *An NPC can enter a maximum of One (1) athlete for BC-3 Category for Male & Female.*
 - *Exceptions may be granted via the Bipartite Commission Invitation method.*
- **Pairs**
 - *An NPC can enter a maximum of one (1) pairs for the following events:*
 - BC-3 (Male & Female)

Entry into Singles Events from Pair

Both players of pair that qualifies for their Men's or Women's Pair event automatically gain entry into their respective Individuals events and are obligated to play in those events.

Male BC-3 player who qualifies in the Pair event automatically gains entry into his respective Singles event and is obligated to play in that event.

Female BC-3 player who qualifies in the Pair event automatically gains entry into her respective Singles event and is obligated to play in that event.

INVITATION is extended to all Member-Nations	To be eligible to participate, athlete/team must be a member of the NPC, and the national federation must be in good standing with World Boccia and the APC.	
SELECTION based on the MQS	Athlete/Team is selected based on the accumulation of points through various World Boccia sanctioned international competitions and based on the Minimum Qualification Standard set for the Games.	
	BC1/ BC2 Team: must be ranked within the top six APC member-nations from the World Boccia World Ranking List.	6
	BC3 Pair: must be ranked within the top six (6) APC member-nations on the World Boccia World Ranking List.	6
	BC4 Pair: must be ranked within the top six (6) APC member-nations from the World Boccia World Ranking List.	6

1 January 2024	Start of the qualification period for athletes to achieve MQS through World Boccia sanctioned international competition.
10 October 2025	Deadline for NPCs to submit the Entry by Number to World Boccia, APC and AINAPGOC.
31 December 2025	End of the qualification period for athletes to achieve MQS performances.
1 May 2026	Deadline for NPCs to submit in writing the members of their Team, Pair BC3 and/or Pair BC4, and Bipartite Application to World Boccia.
1 June 2026	World Boccia notify NPCs in writing of the Bipartite Commission Invitation qualification slots.
31 July 2026	Deadline for NPCs to submit the Entry by Name to World Boccia, APC and AINAGOC
18-24 October 2026	Aichi-Nagoya 2026 Asian Para Games
