

1. The word "TENDER ENQUIRY" for supply of Boccia Sports Kit & Sports Equipment should be super scribed on the top left corner of envelope bearing the name and address of the tendered. The sealed Tenders Enquiry should accompany the following: -
  - A. EMD amount of 100000/- (Rupees one lac only) through crossed Demand Draft drawn in favor of the Boccia Sports Federation of India. **(To be submitted in Envelope -A) cost of downloaded tender form Rs.1,000/- (Rupees one thousand) only should be submitted separately in form of demand draft, if tender form is downloaded.**
  - B. Tender documents duly signed by tenderer having name of tendered/Brand along with list of equipment as per performs at Annexure "II" **(Envelop-B).**

In case of rate quoted for branded item, a **certificate from the firm authorizing distributor/dealership of such item or a certificate regarding being manufacturer, should be attached with the tender documents.**

The tendered are submit an undertaking to the effect that the rates quoted for each equipment are as per specification at Annexure II-B of this tender and any discrepancy found later the whole amount will be recoverable from the security Money deposited.
16. These are only proposed draft terms and conditions and can be modified, changed or added to at the time of finally concluding and signing the agreement.
17. Tenderer are required to quote for only one of its best and economical brands of an item.
18. All tenderer will mention technical detail and specification as enclosed in appendix of Annexure – II-B.
